MEMORANDUM

Whereas Show Cause Notice No. BPSC/EB/2022/70, dated 16th August, 2023 was served upon you Mr. Ateequllah S/o Abdul Ghafoor regarding using unfair means in the Written Exam held on 12th June, 2023 for the post of Assistant Sub Inspector (B-11) in the Coastal Highway Police N-10, Balochistan. You were issued Roll No.3355 to appear in the Written Examination held on the said date. However, during taking attendance, it was revealed that your brother namely (Mr. Samiullah S/o Abdul Ghafoor) was appearing on your place.

Therefore, both of you (Mr. Ateequllah S/o Abdul Ghafoor and Mr. Samiullah S/o Abdul Ghafoor) were called to appear before Scrutinizing Committee (S.C) on 22nd August, 2023 at 1:00 PM in order to clear your position. Moreover, during the hearing your real brother (Mr. Samiullah S/o Abdul Ghafoor) admitted that he endeavoured to appear on your place and also given the confessional statement.

On the basis of documentary evidence and confessional statement given your brother before the Scrutinizing Committee (S.C) of the Commission. It has been established that both of you committed an offence which is contrary to the standing rules and in Exercise of powers conferred under "Instructions Regulating Conduct of Candidates in the Examination Hall and Penalties for Breach Thereof". Therefore, Your (Mr. Ateequllah S/o Abdul Ghafoor) candidature for the post of Assistant Sub Inspector (B-11) in the Balochistan Police Coastal Highway Police N-10, Balochistan is hereby cancelled and further both of you (Mr. Ateequllah S/o Abdul Ghafoor and Mr. Samiullah S/o Abdul Ghafoor) are hereby **debarred** for a period of **two (02) years** from applying or appearing in any examination/ test/ interview of Balochistan Public Service Commission.


