**Qualification:** Graduate from a recognized University with LLB degree.

**Physical Standard For Male:**

- Minimum Height = 5'.5"
- Chest Measurement = 32'x33" -1/2
- Medically Fit

**Note:** Those Candidates who do not fulfill the condition of Height/Chest are not Eligible.

**Age Limit For Male:**

18 to 32 years on closing date for receipt of applications.

(Note: Upper age limit in respect of in service candidates from the Police Department for the post of PI shall be 35 years.)

**Physical Standard For Female:**

- Minimum Height = 5'
- Medically Fit

**Note:** Those Candidates who do not fulfill the condition of Height are not Eligible.

**Age Limit For Female:**

18 to 30 years on closing date for receipt of applications.

**Gender:** Both Male & Female candidates are eligible.

**Syllabus: 1<sup>st</sup> Paper of 100 Marks on English and General Knowledge:**

- English Essay 20 Marks
- Précis Writing (English) 20 Marks
- English Grammar 20 Marks
- General Knowledge relating to Pakistan 40 Marks

**2nd Paper of 150 Marks on Criminal Law:**

- Pakistan Penal Code 50 Marks
- Criminal Procedure Code 50 Marks
- Evidence Act (Qanoon-e-Shahadat) 50 Marks

**Note:** Only those candidates will be called for viva voce test, who qualifies the written exam and fulfill the required physical standard.
