The date and time of viva voce test of the above candidates will be notified in due course of time.

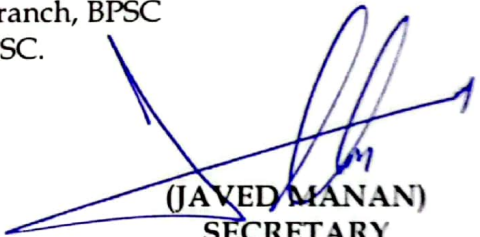
